Objectives

After the course, the student will have basic knowledge and abilities in these fields:

- investment- and product-choice theory
- economic optimisation of typical forestry decisions
- Inventory and stock level problems
- Economic calculations and decisions concerning machines
- Rotation problems
- General one-dimensional optimisation with applications
- Fundamental linear programming with applications.

Content

The course contains product and investment theory and calculation and economic optimisation with connection to forestry decisions.

Implementation

Lectures by invited speakers ca 4 h (compulsory)

Excursion and Exercises ca 8 h (compulsory)

Exercises and Seminars ca 108 h (compulsory)

Examination**Requirements for examination**

Written exam and essay-writing

Passed exam and essay. Presentation/opposition and participation in field exercises.
