The requirements for attaining different grades are described in the course assessment criteria which are contained in a supplement to the course syllabus. Current information on assessment criteria shall be made available at the start of the course.

Prior knowledge

Basic knowledge about forestry such as Forestry for Agricultural and Rural Managers, 2 Swedish University Credits (SUC), or other basic courses about forestry.

Objectives

Having completed the course the students will be able to make a simple forest management plan. They will also have knowledge of the costs and income from forestry, understand different silviculture operations, and be aware of concerns for nature and biodiversity.

Content

During the course the students make a forest management plan of a small forest area. The work includes most aspects of forestry; forest menstruation, silviculture, costs for e.g. harvest of trees and income from selling timber. The plan will also include concerns about nature and biodiversity. During lectures and excursions the students get facts about, e.g. silviculture and the timber market, that help them in their work with the management plan.

Implementation

- 1 week of field work (forest menstruation, silviculture)
- 1 week at a forest technician school (forest technique and wood technology)
- 2 weeks of lectures and exercises (in Alnarp)
- 1 week of excursions and field trips (in Southern Sweden)

Examination

Requirements for examination

Written forest management plan and examination.

Approved forest management plan and passed examination. Participation in compulsory items.

- If the student fails a test, the examiner may give the student a supplementary assignment, provided this is possible and there is reason to do so.
- If the student has been granted special educational support because of a disability, the examiner has the right to offer the student an adapted test, or provide an alternative assessment.
- If changes are made to this course syllabus, or if the course is closed, SLU shall decide on transitional rules for examination of students admitted under this syllabus but who have not yet passed the course.
- For the examination of a degree project (independent project), the examiner may also allow the student to add supplemental information after the deadline. For more information on this, please refer to the regulations for education at Bachelor's and Master's level.

Additional information

- The right to take part in teaching and/or supervision only applies to the course date to which the student has been admitted and registered on.
