## **Prior knowledge**

The equivalent of: 20 Swedish University Credits (SUC) in biology and 10 SUC in chemistry

## **Objectives**

The course presents basic knowledge about microorganisms, especially bacteria and viruses. The techniques of microbiology are practised.

## **Content**

Definitions of microorganisms. The systematics of bacteria. Structure, nutrition and growth of bacteria. Structure and reproduction of viruses. Sterilization and disinfection. Antibiotics. Microorganisms in soil. The role of bacteria in the cycling of elements. Interactions between microorganisms and plants. Bacterial genetics and gene technology.

Seminars ca 12 h (compulsory)

## **Examination**

### **Requirements for examination**

Written or oral test and written and oral presentation of laboratory work.

Passed tests, participation in compulsory course components and in course evaluation.
