Prior knowledge

The equivalent of: 60 Swedish University Credits (SUC) in Landscape Planning or Architecture and Spatial Planning, of which 20 SUC at advanced level (C-level).

Objectives

On completion of the course, students will:

- have knowledge of the landscape and social development from a regional perspective, focussing on northern Sweden
- have practised and developed the ability to describe and analyse landscape on a regional scale
- have knowledge of plant material and plant use in severe climates
- have developed the ability to co-operate with other professionals in specific projects.

Content

A two-week study trip along a section through the northern Swedish landscape gives a background to the region's conditions. Lectures and seminars deal with northern Scandinavia's special characteristics, regional development conditions and plant conditions in depth. The content of the project work, for example a particular location's conditions for development or a survey of resources and obstacles for sustainable development in the north, is decided in consultation with the course leaders.

Implementation

Lectures ca 20 h

Seminars ca 30 h (compulsory)

Exercises ca 60 h

Study trip ca 80 h (compulsory)

Examination**Requirements for examination**

The course is assessed partly through active participation in the study trip and seminars, and partly through carrying out and reporting project work.

Participation in the study trip and seminars, pass in performed and reported project work.

- If the student fails a test, the examiner may give the student a supplementary assignment, provided this is possible and there is reason to do so.
- If the student has been granted special educational support because of a disability, the examiner has the right to offer the student an adapted test, or provide an alternative assessment.
- If changes are made to this course syllabus, or if the course is closed, SLU shall decide on transitional rules for examination of students admitted under this syllabus but who have not yet passed the course.
- For the examination of a degree project (independent project), the examiner may also allow the student to add supplemental information after the deadline. For more information on this, please refer to the regulations for education at Bachelor's and Master's level.
