Prior knowledge

Five semesters of study at the MSc in forestry programme, or the equivalence.

Objectives

After the course the student will have basic knowledge of law and relevant legal areas for foresters and some skill in solving basic problems.

Content

The course starts with a bit of common jurisprudence and an overview of the forensic sources engaged when solving legal problems. Then the legal right of access to private land is dealt with, parts of the environmental- and EC-law as well as aspects of criminal law.

Implementation

The teaching is carried out through independent work in basic groups, lectures and seminars. The seminars are mandatory and prepared in the basic groups. The teaching relies on problem-based learning. Each student must write a memo. The memo is compulsory.

Lectures ca. 5 hrs

Seminars ca. 10 hrs (compulsory)

Work in basic groups and Memo-writing ca. 65 hrs

Formats and requirements for examination
