Objectives

The student will get an introduction to how to study and work at an university, the tools needed to be able to on his/her own initiative, all through the education, be able to critically scrutinize and scientifically analyze i.e. the essential questions dealing with care and cultivation of the living resources of nature. The student will get basic knowledge in computing, the structure of the university library and its searchsystems, and insight into and experience of how to write and orally present an essay.

Content

The course consists of:

Introduction to the programme and SLU, introduction to computers and libraries at SLU, lectures and excersises in study technique and oral and written presentations. The student will write an essay under supervision, present the essay and participate in conference with seminars on different themes.
